RECESS TO BUDGET HEARING at 7:03 pm – President Leo read the following:

BUDGET HEARING STATEMENT OF FACT

The Aurora Fire District has met the budgetary requirements as per the Oregon Department of Revenue. The Aurora Fire District Budget Committee met on May 20, 2020 and was presented with a proposed balanced budget for FY 20 /21, which they unanimously approved. The appropriate public notifications have been published via the Canby Herald and District website. Staff is pleased to make a recommendation to our Board of Directors to approve the Aurora Fire District FY 2020 / 2021 Budget, in the amounts categorized for General Fund appropriations, as was unanimously approved by the Budget Committee, and as is presented here tonight with topographical errors corrected. Everyone was in favor.

CONSENT AGENDA

Been training with CCOM and transfer scheduled on July 1, at 8 am.

➤ Ehlen Rd. property update – Progress is being made, the driveway has been completed and looks great. There are now two 40-foot high conex containers on the property, along with some cars for extrication training. Operations Chief Greg Dyke is working to get the security established. The fence and gate will be done toward the end of July, along with a sign being printed and a solar-powered light post. The sign will be basic, with just the new Aurora Fire District logo on it and address. Chief shared via his computer screen the layout of the sign – emphasizing that it's a training center, not a fire station. The goal was to keep it simple and easy to read from the road.
